AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING
THE MAYOR OF THE CITY OF PIEDMONT TO EXECUTE
ANY AND ALL DOCUMENTS FOR PURPOSES
OF THE PIEDMONT MUNCIPAL AIRPORT
STATE BLOCK GRANT PROGRAM
PROJECT NO.; 20-070A-1
AMENDMENT #1

WHEREAS, the City of Piedmont is planning improvements to the Piedmont Municipal Airport, for reconstructing the entrance road and bridge; and

WHEREAS, the parties entered into an Agreement executed by the Sponsor on September 14th, 2020, and executed by the Commission on September 25, 2020, under which the Commission granted the sum not to exceed One Hundred Forty-Two Thousand Nine Hundred Fifty-Two Dollars (\$142,952) to the Sponsor to assist with Reconstruction Entrance Road and Bridge; and

WHEREAS, the Commission previously approved funds for Reconstruction Entrance Road and Bridge; and

WHEREAS, the level of funding originally approved is not sufficient to cover the costs associated with Reconstruction Entrance Road and Bridge, and the Commission has sufficient funds to increase the grant amount for said project; and

WHEREAS, the Commission grants to the Sponsor an additional sum not to exceed Five Hundred Thirty-Three Thousand One Hundred Eighty-Two Dollars (\$533,182) For Reconstruction Entrance Road and Bridge subject to all conditions:

- (A) The amount of this grant stated above represents Five Hundred Three Dollars (\$503) at Ninety Percent (90%) of eligible project costs and Five Hundred Twenty-Eight Thousand Six Hundred Fifty-Two Dollars (\$528,652) at One Hundred Percent (100%) of eligible project costs.
- **(B)** The Sponsor shall provide matching funds of not less than Five Hundred Three Dollars (\$503) toward the project in addition to those previously committed by the Sponsor in the Original Agreement.
- **(C)** The project will be carried out in accordance with the assurances (Exhibit 1) given by the Sponsor to the Commission as specified in the Original Agreement.
- **(D)** This Amendment shall expire and the Commission shall not be obligated to pay any part of the costs of the project unless this grant amendment has been executed by the

- Sponsor on or before March 1, 2022, or such subsequent date as may be prescribed in writing by the Commission.
- **(E)** Based upon the revised project schedule, the original project time period of December 31, 2021, will be extended to December 31, 2022, to allow for completion of the work. Paragraph (2) of the Original Agreement is hereby amended accordingly.
- **(F)** All other terms and conditions of the Original Agreement entered into between the parties shall remain in full force and effect.

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED BY THE BOARD OF ALDERMEN OF THE CITY OF PIEDMONT, MISSOURI that the Mayor is authorized to execute any and all documents regarding Amendment #1 of Project 20-070A-1 for the Reconstruct Entrance Road and Bridge Project.
