A RESOLUTION ADOPTING BID PROTEST PROCEDURES FOR WATER BID

WHEREAS, the Piedmont Public Water Supply in the process of making improvements to the water system to serve their customers;

WHEREAS, such water project requires a public bidding process in order to award a contract for construction of the system; and

WHEREAS, procedures must be adopted to handle protests, claims, disputes, and questions that may arise during the bidding process;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE PIEDMONT WATER DEPARTMENT, THAT THE BID PORTEST PROCEDURE SHALL BE CONDUCTED AS FOLLOWS:

- Section 1. In the event, any protest, dispute or claim arises out of procurement as related to this contract, prior to bid opening, must be filed by certified mail with the City Clerk within fifteen (15) days of bid opening. Any such protest, dispute or claim shall state in detail its basis.
- Section 2. In the event that a protest, dispute or claim arises out of procurement as related to this contract, following bid opening, the following procedures shall be followed for filing, review, and resolving said protest, dispute, or claim:
 - A written protest, dispute or claim must be filed by certified mail with the City Clerk.
 - 2. The basis of protest, dispute or claim must be explained in detail.
 - 3. The contract provision relating to the protest, dispute or claim must be cited.
- Section 3. The City Clerk will notify the Mayor within three (3) calendar days of receipt of any protest, dispute or claim.
- Section 4. Within fourteen (14) days of receipt of protest, the Mayor will consult with the City's Attorney and will act upon the claim in one of the following actions:
 - 1. Deny protest, dispute or claim.
 - 2. Concur and agree protest, dispute or claim.
